In order to still provide an opportunity for all interested parties to share their views with us, we will now hold further virtual consultations on the below dates.

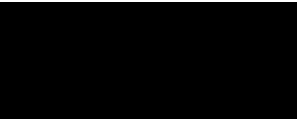
