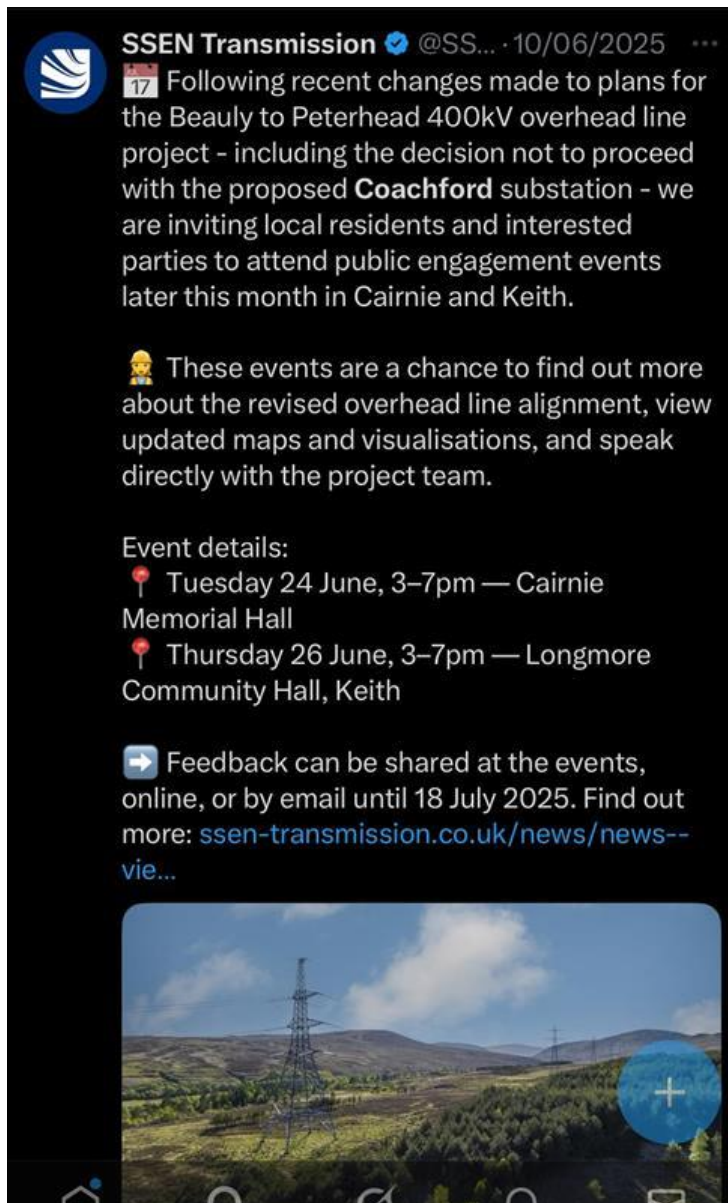

#### Proposed Alignment Design Changes - Consultation Event

Following the decision to not progress with the proposed Coachford substation, we are hosting two consultation events for the Beauly-Peterhead 400kV overhead line project to present our proposed alignment design changes within Alignment Section 19 and 20.

These events conclude our engagement prior to the submission of our consent application under Section 37 of the Electricity Act 1989.

To enable the growth in renewable developments needed to facilitate the country's drive towards net zero, investment in our network infrastructure across the north of Scotland is required to connect this power and transport it to areas of demand.

We will be sharing our amended design and proposed alignment for the development to the east and south east of Keith, including details on how this decision was taken. This will be presented on maps and visualisations with a booklet and handouts available for attendees. Digital versions are available to download within the documents tab on our project web page.

Interested parties can attend our drop-in events to discuss our plans with the project team and share your thoughts on the alignment ahead of the submission of our application for Section 37 consent in early Autumn.

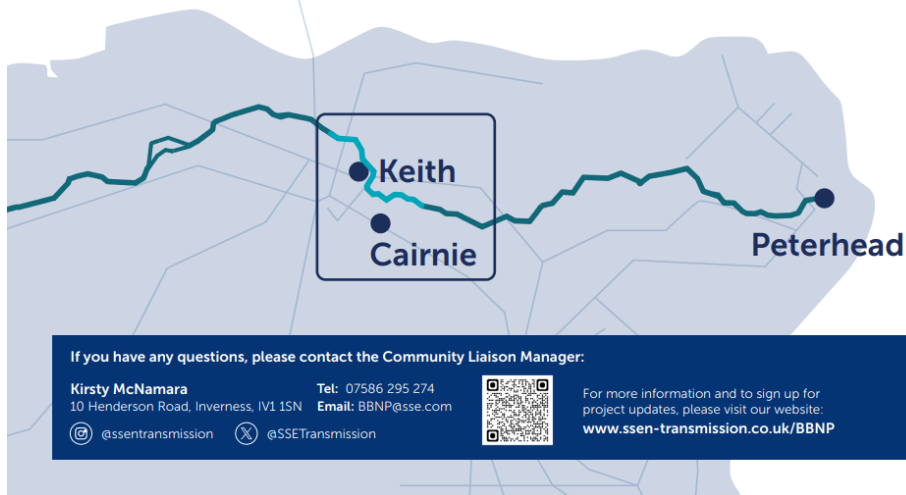
