## APPENDIX 10.1: CULTURAL HERITAGE ASSETS IN THE INNER STUDY AREA

This appendix provides details on the heritage assets recorded in the Inner Study Area identified through desk-based assessment and field survey, together with an assessment of their heritage sensitivity, the predicted construction (direct) effects on each heritage assets, proposed (additional) mitigation and the predicted residual effect.

The appendix should be read in conjunction with Chapter 10: Cultural Heritage, Section 10.4: Baseline Conditions and Section 10.5: Assessment of Effects.

The locations and extents of the recorded heritage assets within the Site are shown on Figure 10.1a-c Cultural Heritage: Inner Study Area.

They mark the boundary between the former parishes of Fordoun to the south and Strachan to the north.  Their locations of the boundary stones are: (a) 367357, 781521; (b) 365237, 780987; (c) 366038, 781292; (d) 366229, 781903; (e) 367992, 781698; (f) 365636, 781096; (g) 365853, 781097; (h) 366879, 781760.  One stone (h) lies within the LoD corridor.  Field survey identified stone (h) at 366877, 781765. The stone was marked with a S on one side and F on the other presumably to show the sides of the parishes the stone was marking. The boundary stones measured 0.3 m in width and 0.4 m in height, located atop a flat plateau next to forestry (Drumtochty Forest). None of the other boundary stones lie within the Inner Study Area and therefore were not visited during the field survey. Field survey identified the triangulation pillar which appears to have replaced an earlier boundary stone (3), which was found next to the triangulation pillar. Walkover survey by Rathmell Archaeology in 2021 ahead of proposed woodland creation (HER NO78SW0076) at Bankshead recorded only a small oval mound of stones c.8.5 m by 3.5 m and standing up to 0.5 m, with evidence of concrete/cement. It was noted that nothing survived of the enclosure surrounding the cottage.  Field survey for this assessment identified remains of the cottage which survives as a rectangular area with large stones covered by grass on the edge of forestry and the possible remains of an enclosing bank shown on the 2nd edition Ordnance Survey map (1904⁴) at the cottage's western boundary. The area of the cottage and enclosure measured: 53 m x 14 m with height of the remains recorded as 1 m, while the platform measured 10 m x 5 m with a depth of 0.5 m-0.8 m.

The Mill Pond was visited during the walkover survey and found to still exist along with what may be the remains of a concrete dam.  The walkover survey also found that part of the dry-stone boundary wall survives. The existing field track runs along the side of some of the rectangular buildings depicted. The old mill pond is still visible and the farmstead is currently occupied which measures 40 m x 20 m. The old boundary wall measures 212 m x 1 m at a height of 0.5 m-1 m. The pond however is still shown on aerial photography (Google Earth⁵). The farmhouse, early 19th century, is a plain two-storey building, harled with a slate roof. The building is also listed as a Category C listed building. The building was visited during the initial walkover survey, and it was found that the building is now derelict and in a poor state of repair. The possible outline of the former road running from 372070, 782651 to 372170 782492 is visible on modern aerial photography.
